## **CCSB Administration Committee Meeting** – Elizabeth Hutchins

EVHS and CCHS have both been recognized as Blue Star Schools. This is based on the C&T enrollment, number of certification tests given, and other things. Each teacher shared what projects, contests, and activities the students were currently working on. In addition, the CCHS Reality store (Oct. 8) and the EVHS Reality store (Oct. 16) were highlighted.
