A meeting of the School Board of Culpeper County was held March 14, 2016 at the Board of Supervisors Meeting Room at 302 N. Main Street, Culpeper, VA 22701. Delegations

Mr. Clancy said persons may present ideas or concerns regarding Culpeper County Public Schools. He said there would be no action taken by the Board at this meeting and that such items would be referred to the appropriate administrators for future information and research. He said the personalities and behavior of employees are not to be presented during this period but are to be reported to the employee's immediate supervisor. Mr. Clancy noted there would be a three minute limit for speakers.

Matt Ortman (CCEA President) – Mr. Ortman shared with the Board that has worked for Culpeper County Public Schools for 13 years and currently is an ITRT. He noted that CCEA supports the budget being presented to the Board this evening. He noted that CCEA members in the audience are wearing "Red" not only to identify themselves, but to remind Board members that it is time to stop budget cuts. "Red" means stop.

Consent Agenda

On motion of Ms. Luckinbill seconded by Ms. Hutchins, the School Board considered approving the consent agenda.

Ms. North noted a discrepancy under GBO BR-1 (Extended Service Program) Compensation Section B3 relative to "the participant's daily rate and the applicable substitute/temporary hourly rate". She explained it should be one or the other not both. Dr. Timmons agreed. He stated that "and" should be replaced with "or".

Ms. North moved to amend the verbiage by removing "and" and replacing it with "or" in the Extended Service Program Compensation Section B3. Seconded by Ms. Smith. The amendment carried on a 7-0 voice vote.

Ms. North noted that under GBO E1 (ESP – Agreement and Signature Form) the statement relative to health insurance should be removed because ESP participants do not receive benefits. Dr. Timmons noted that was correct; however, it was actually left on for record keeping. Dr. Brads reiterated that it had nothing to do with ESP; it is just for record keeping.

The consent agenda was approved as amended. Motion carried 7-0 by voice vote.

The board considered the following action items:

(a) Approval of FY'17 Operating Budget

Dr. Brads said he would appreciate the Board's approval of the proposed spending plan. He said ultimately it is the School Board's Plan because the Board directed staff to develop a plan that attempts to get salaries more competitive in the market with the school divisions we compare ourselves to. He noted that the county and school system plan to move to self-funded insurance vs. fully funded. He said self-funded will reduce some of the fees currently associated with fully funded. He noted that both the county and school system plan to hold employees harmless relative to insurance. He respectfully requested the Board approve the proposed plan so the division can move forward with presenting the plan to the Board of Supervisors at their meeting tomorrow.

On motion of Ms. Smith seconded by Ms. Baker, the School Board approved the FY'17 Operating Budget. Motion carried 7-0 by voice vote.

(b) <u>Approval of Regulation Changes and Policies/Regulations for Section F Reassigned to Board Regulations (BR) or Superintendent Regulation (SR)</u>

On motion of Ms. Luckinbill seconded by Ms. Smith, the School Board approved the regulation changes and reassignments.

Ms. Hutchins noted there were grammatical errors on FECBA-BR2 (School Division Recycling Program) that needed to be corrected before it is posted.

Motion carried 7-0 by voice vote.

The Board heard the following staff reports:

(a) Finance Report

Mr. Shomo said the FY'16 budget was built on an ADM of 7,979 and the February 29th count reflected a membership of 7,965.

Mr. Shomo noted that accounts payable approved this evening totaled \$456,503 and the March 2015 accounts payable was \$373,329.

Mr. Shomo shared with the Board that fuel costs are still holding steady. He estimated the fuel savings for the year to be \$441,577. He said the goal is to use the fuel savings to replace the 2005 and 2006 busses with 4-5 new 77 passenger busses.

Mr. Shomo shared with members the utility costs for February 2015 and 2016. He noted that the costs decreased by \$6,148.

Mr. Shomo briefly reviewed the current capital projects:

- ➤ CCHS renovation extensive punch list (HVAC/controls)
- ➤ CCHS agriculture storage building finalizing punch list
- ➤ AGRES/PSES road entrance DEQ made additional comments, waiting on geotech borings
- ➤ Vestibules all reimbursements approved waiting on funds, second phase of cameras being installed at CCHS
- ➤ CMS gym/locker rooms & SPES roof tops and controls will put out to bid on 3/17/16 with bids due 4/7/16
- ➤ PSES cafeteria serving lines awaiting final design
- > PSES roof obtaining estimates for replacing the remaining of the roof

Mr. Shomo shared with the Board a detailed ledger for all the funds spent on the CCHS renovation. He said to date we have spent \$18,974,774.40 on the project.

(b) Operations Report

Mr. Parkinson shared a PowerPoint with the Board showcasing some of the projects that have been ongoing during the renovation of CCHS:
