Reports

Emerald Hill Elementary School Principal Report – Pamela Gatewood

Principal Gatewood shared with the Board the success the school has had with departmentalizing reading and math. Ms. Gatewood shared a short video about how the staff feels about the double teaching model.

Delegations

Mr. Clancy said persons may present ideas or concerns regarding Culpeper County Public Schools. He said there would be no action taken by the Board at this meeting and that such items would be referred to the appropriate administrators for future information and research. He said the personalities and behavior of employees are not to be presented during this period but are to be reported to the employee's immediate supervisor. Mr. Clancy noted there would be a three minute limit for speakers.

Wendy Young (Salem District) – Ms. Young expressed concern with how a recent discipline incident with her son was handled. She said TRIER does not offer higher academic classes; everything is done online. She said in the future it would helpful to parents if they received a copy of the principal's report prior to a discipline hearing. She suggested the Board reexamine their definition of sufficient cause.

Ron Young (Salem District) – Mr. Young expressed concern with the Student Athlete Drug Testing Policy. He said in a recent incident involving his son the school overstepped their authority and did not follow policy.

(c) <u>Approval of a Request for Proposal (RFP) for professional architectural and engineering</u> services

Dr. Brads shared with the Board that the RFP was discussed with the Capital Planning Committee and they want to move it forward. He said Board members will be asked to participate in the RFP interview process.

On motion of Ms. Hutchins seconded by Ms. Smith, the School Board approved the RFP for professional architectural and engineering services.

Ms. Luckinbill asked where the RFP came from. Dr. Brads said it was previously used in another school division and reviewed by the county purchasing office.

Motion carried 7-0 by voice vote.

The Board heard the following superintendent/staff reports:

(a) Superintendent Updates

Dr. Brads said we had a great start to the school year. Kudos to teachers, staff, and administrators for their hard work which led to the successful opening of school.

Dr. Brads noted that the school division conducted a very productive Pre-School Conference Week. He said we received a lot of positive feedback on the quality of events scheduled and the amount of time afforded teachers in their classrooms.

Dr. Brads thanked the Chamber of Commerce and the school division for a very successful BIE Day on Friday, August 5, 2016 at EVHS. He also thanked Novant Health UVa Health System for providing a mobile mammogram unit onsite during the event.

Dr. Brads thanked the School Board for authorizing the pay period adjustment to align with the school calendar. He said new hires have been paid and returning staff also received their first 2016/2017 compensation.

Dr. Brads highlighted the following:

- ➤ First day enrollment 7,799, 95.4% of the 8181 students on the roll, 372 no shows
- \triangleright Ten day enrollment 8,020.5, 61 no shows
- \geqslant 8/30 enrollment 8,023
- **>** 9/6 enrollment − 8.040
- ➤ FY'17 budget enrollment 8,069

Note – these numbers do not include 143 pre-school students

(b) <u>Finance Report</u>

Mr. Shomo said the FY'17 budget was built on an ADM of 8,069 and the September 6th count reflected a membership of 8,040. He said the decrease in student enrollment translates to a decrease in revenues of \$116,000.

Mr. Shomo noted the accounts payable approved this evening totaled \$671,077 and the September 2015 accounts payable was \$517,319.

Mr. Shomo said diesel fuel was budgeted at \$2.86 per gallon and the last load cost \$1.57 per gallon. He said the estimated usage for the year is 212,000 gallons.

Mr. Shomo shared with members the utility costs for 2015/2016. He said last year we saved \$264,643 and on average it cost \$1.26 per square foot for water/electric/fuel.

Mr. Shomo spoke briefly about the annual school report for FY'15 vs FY'16.

Ms. Hutchins said in a future report she would like to see the difference in heating costs with the new square footage at CCHS and the additional savings with the updated systems, doors and windows.

Mr. Clancy asked what equipment was purchased in the cafeteria. Mr. Shomo said items at the end of their lifespan. He also noted they are looking at moving to convection ovens because they tend to cook the food more thoroughly.

(c) Operations Report

Dr. Timmons shared a brief synopsis of what has been happening in Food Service, Maintenance, and Transportation. (See handout.)

Board Reports

Ms. Baker wished everyone a great start to the school year.

Ms. North said she attended the Career Partners meeting as an alternate for Ms. Luckinbill. She said it was a wonderful meeting and they do such wonderful things. She said she looks forward to serving on the committee.

Ms. Hutchins said she attended BIE and it was wonderful. She said there appeared to be more vendors than ever before. She congratulated all the students recognized this evening. She also thanked everyone for a wonderful opening. She applauded the staff for completing so many projects over the summer.

Ms. Carter said she represented the School Board at the Culpeper Youth Advisory Council meeting. She said lots of ideas were discussed and they have another meeting coming up in October.

Mr. Clancy thanked the Board for a great year and he is looking forward to a new year.
